MINUTES OF THE RANGIORA PRESBYTERIAN PARISH ANNUAL GENERAL MEETING HELD ON SUNDAY 13 SEPTEMBER 2020 AT THE END OF THE CHURCH SERVICE IN THE STEWART AND WYLIE ROOMS

OPENING: The Moderator, Russell Drake, the Chairperson of the Parish Council, invited Rev Jason King, to open the meeting with Prayer at 11.26a.m. There were 60 people present.

APOLOGIES: Brenda McIntosh moved, Alon Mayhew seconded, that the 15 apologies be received. AGREED

MINUTES: The Minutes of the two parts of the 2019 Parish A.G.M. held on 15 September 2019 and 3 November 2019, as circulated were to be taken as read. Russell Drake pointed out that there was an Amendment. The correct wording for the second paragraph on the second page of the 15 September Hannah Hancox that both lots of Minutes of the 2019 A.G.M., including the Amendment be confirmed AGREED.

NEW ELDER AND PARISH COUNCIL NEW MEMBERS: Russell Drake explained that the Parish Council required 2 new members to fill vacancies and as advised on Sunday 6 September 2020, two people were being put forward for this – Anne Moffat, who has been an Elder in another Parish and Kayla Crampton. Annette Paterson moved, and Mary Stewart seconded that Anne Moffat be received as an Elder for our Parish and that both Anne and Kayla be appointed to the Parish Council. They then both left the meeting while voting took place. Russell Drake asked that Scrutineers be appointed. Hudson Deane moved, and Jill Drake seconded that John Kennedy and Barbara Peacock be appointed Scrutineers. This was AGREED. The voting papers were handed around for Members and Associate Members. The votes were collected, and the Scrutineers went to count them.

REPORTS: Russell Drake had pointed out earlier that there was a correction in the Barnabas Trust Annual Report; The Balance as at 30th June 2019 should read - \$5,656.90. The bulk of the Annual Reports including the correction, were put to the meeting for approval. After a time for discussion Brenda McIntosh moved, Mary Stewart seconded that the reports be adopted AGREED.

FINANCE REPORT: Hannah Hancox moved, and Alan Mayhew seconded that the Financial Report for year ended 30 June be adopted AGREED. Hudson Deane then asked that a vote of thanks be given to Tracy Mayhew who works in the Parish office as a volunteer. This was noted. Russell Drake then added a vote of thanks to Richard McMurdo and John Hannah who along with Tracy Mayhew had worked as part of the Finance Team.

BUDGET 2020: Discussion on the Budget for the next financial year ensued. Bruce Morriss stated that a Budget of negative \$27,000.00 was not acceptable and

commented that the offering budget figures had been declining over the last two years and had the Parish Council looked at ways of turning this around such as the salary of the Youth Worker?

Russell Drake acknowledged that two weeks ago on Budget Sunday, he had talked to the congregation about the deficit in the budget. Rev Jason King also affirmed that the Parish Council is reviewing the Youth Worker's hours but stated that this is not the right time to remove the Youth Ministry. Hudson Deane stated that he was speaking against the budget and asked the Parish Council to please consider other ways to meet the budget. Russell Drake advised that the Parish Council are looking at options to support change and mentioned that we need Faith to face problems and needs and asked that the Parish Council be given more time to work on the changes needed. Alan McIntosh asked why all the interest gained from investments had not been added to the accounts? Tracy Mayhew advised that the Finance Team wanted to present the budget without the interest showing as income as the investments may not be there forever. Hudson Deane asked why the budget figures for last year for the Assembly Assessment and the Presbytery Levies were actually less than those budgeted for last year? Rev Jason replied that we had been given a discount for the effects of the Covid 19 Lockdown. Lynette Fowler asked if the figures for the income from the Church Fair for last year were included in the overall fundraising figure. Russell Drake affirmed that they were. Following a show of hands as to who agreed or disagreed with the budget, Annette Paterson moved and Merv Hamilton seconded that the Budget be approved AGREED.

VOTE RESULT: John Kennedy brought the result of the earlier vote to the meeting.

Anne Moffat had 49 votes of approval and 2 abstentions for both, being inducted as an Elder and as a member of the Parish Council.

Kayla Crampton had 49 votes of approval and 1 No, as a member of the Parish Council.

Anne and Kayla were congratulated on their success.

The Scrutineers were thanked. Tracy Mayhew moved and Jill Drake seconded that the voting papers be destroyed AGREED.

AUDITOR: Annette Paterson moved and Tracy Mayhew seconded that Glenda Greenwood be thanked for her work in Auditing the accounts and approved as the Auditor for the next year AGREED.

Ministers Report

The Church is constantly reforming. After we returned after the COVID-19 restrictions we needed to try to re-settle back into our shape of Mission and Ministry in a very public sense. For some this was easier but for others it was a challenge. Through this all we are constantly asking the question: "God where are you leading us?"

We are convinced that the way God is leading us this year is different from last year and will be different again next year. This change can be difficult if we are used to consistency and a very clear path. But we are acutely aware that sometimes God doesn't make the water firm until we step out of the boat.

At the end of 2020 the Parish Council identified 5 key areas of discussion which we need to be addressing in 2021. (In no order of importance):

Church Rebuild

Ministry Leadership

Youth Worker

Big Picture

Families Mission/Ministry

We have spent much time discussing these things this year and will continue to seek God's wisdom through the next year as we unpack the realities of these areas in our life as a Christian Community. I have found the conversations around each of these parts of our Church life to be very enriching and challenging at the same time. Probably the biggest question we will be asking is, who does God want us to be? What is the big picture or the big dream for John Knox Rangiora? Do we have long term viability? Do we want to continue to seek to be a "Church for all ages?" If so, how will we direct our attention to make this so? With the challenge of decreased involvement from our wider church community, how will we sustain our mission and ministry? How will we engage with our community in ways that give us divine appointments to reveal the hope and life of the Kingdom?

I am excited about the opportunities we have in front of us. I am mindful of our rich history and solid expressions of worship that have flourished over the last 149 years. What excites me most is exploring the relationship between the two. I'm deeply committed to being a "Church for all ages" especially in terms of a Church community where my family can experience God in real and relevant ways. Where the unchurched and the de-churched can find a place. But I'm also mindful that this is not always easy for many of us who are not accustomed to change and risk and pioneering and pushing the boundaries of what Church can become.

My Prayer, looking into 2022, is that we will not be afraid to try but find strength in our common journey and show patience for when we don't get what we want when we want. Because sometimes we get it wrong and when we do get it wrong may we also show grace to one-another because in the end we are all fellow travellers hoping to hear from God and to live according to His dream for John Knox Rangiora.

ADMINISTRATION MINISTRY

Finance Team Report:

- **Finance Team**: Our Finance Team has been meeting monthly to manage and report on the finances. A big thank you to Tracy, Richard and Margaret for their management and direction.
- **Finance Email**: There was a little confusion around the use of the finance@johnknoxrangiora email address so we have chosen to discontinue this address in to 2022. We will use only the admin@johnknoxrangiora address and then redirect any email to the individual team members.
- **APW**: This year Tracy has been working with our APW group on adopting internet banking and helping them transition.
- **2021 Financial Position**: At last Year's AGM we passed a brave budget with a Deficit of \$27,011. This year we saw an increase in our giving and a significant increase of church members giving online via direct debit due to Cheques being phased out. Our giving increased by 3% from \$114,335 to \$117,810 and our Fundraising has increased by \$5,903 once expenses were removed. This resulted in a deficit of just \$7,977.

Over the last year we also completed commitments from the previous financial year from 2019-2020 of \$6,717. These payments, made in this financial year, were commitments from last year.

- o SIM \$2,000
- Light Party \$500
- Laidlaw \$1,000
- o OMS \$1,000
- o CBM \$1,000
- Stipend correction \$1,217

While we have worked hard to ensure our payments happen in the correct financial year *this* year, there is one payment to *24-7* of \$2,231 which we paid in July 2021 which was due in the previous financial year.

So while our figures for 2020-2021 look good with a deficit of \$7,977 (as opposed to a deficit of \$27,011), when we calculate payments in the appropriate year it is only a deficit of \$3,491. This is an outstanding effort and while it is not the balanced budget we wanted, it shows the commitment and ownership from the JKR community.

• **Investments**: We haven't had to draw on interest from our Building investments this year which is also a positive step. Last year John Hannah spent time researching what investments we had and what their purpose was for. Over the last year, with interest rates of 1.75% we received \$30,823 in interest. Of this \$5,196 was interest tagged for Housing Allowance.

- Budget Process: As part of our Budget process, we have followed previous years and drafted a Budget for the Parish Council to review in June. This is then presented to the Parish during a Sunday Service called "Budget Sunday" where feedback and discussion is received and reviewed. The final Draft Budget is then approved by the Parish Council before being presented to the Parish at the AGM. This process is made so much easier through the hard work Tracy puts in with the finances each month, the Xero software we use and the introduction of Interned banking over the last 18 months.
- Transition: Over the next year the Finance Team will be bringing into the team another member as I am stepping down as Chair. The last 18 months has been a tough but a good transition from a Treasurer and Managers set-up to a Finance Team. I am confident in the management and direction of the Finance Team and have enjoyed working alongside the team as we have built a fun and relaxed culture alongside efficient and robust financial processes. If you feel you would like to be involved in our Team or have any questions looking into the next year, please come and have a chat with our current team.

'How did we do our accounting?'

Basis of Preparation

The entity has elected to apply PBE SFR-A (NFP) Public Benefit Entity Simple Format Reporting - Accrual (Not-For-Profit) on the basis that it does not have public accountability and has total annual expenses equal to or less than \$2,000,000. All transactions in the Performance Report are reported using the accrual basis of accounting. The Performance Report is prepared under the assumption that the entity will continue to operate in the foreseeable future.

Goods and Services Tax (GST)

The entity is registered for GST. All amounts are stated exclusive of goods and services tax (GST) except for accounts payable and accounts receivable which are stated inclusive of GST.

Income Tax

John Knox Presbyterian Church, Rangiora is wholly exempt from New Zealand income tax having fully complied with all statutory conditions for these exemptions.

Bank Accounts and Cash

Bank accounts and cash in the Statement of Cash Flows comprise cash balances and bank balances (including short term deposits) with original maturities of 90 days or less.

Changes in Accounting Policies

There have been no changes in accounting policies. Policies have been applied on a consistent basis with those of the previous reporting period.

Thank you Brenda for your hard work to host us. Another day out was to 'Tall Oaks' where Frances Taylor hosted us in her beautiful home with a sumptuous afternoon tea then walked us round her 3 acre Garden Park. We enjoyed wandering round this springtime wonderland. Thanks to Frances for her hosting that day. In April we had an Easter theme to our Devotions and Programme. In May we were treated to Mary Stewart sharing with us the story of how Operation Coverup started and what they do. She had a book about the organization with great pictures to help her tell us an interesting story. Last September's meeting we had visitors from the Salvation Army Women's Group and one extra from our church as well as our 9 members to hear Gabrielle O'Connell speak about her job as Coordinator of North Canterbury Centre of the Cancer Society. This group had only started up earlier in the year so was very interesting to hear the work they are doing in our community.

Twice during the year - in August then in March – 4 of us went to Christchurch to share morning tea with some of our friends we used to meet with at Presbyterial monthly meetings. These were held at the Oderings Café and at the home of Helen Gunn. Always good to catch up with old friends.

For a number of years now we have sent a letter monthly to and several times a year visited our Adopted Patient – Eleanor Hunt. Sadly, we learned at our November meeting that Ellie had died a few days earlier. Unfortunately none of our members could get to her funeral but a message was sent to her carers.

We continue to take goods to the Pillars at Christmas. They look after the families of prisoners and are always very appreciative of the gifts we – and some other Church Women's Groups – give to help make Christmas a special time. Members of our Church Congregation also helped us with this project and we thank them very much for their support here.

For several years we have supported Mel Laird as a missionary with Mission Aviation Fellowship in Arnhem Land, Northern Australia. Just before Christmas we learnt the Mel was leaving MAF and coming back to New Zealand in January. So at the moment we do not have a missionary to support. We reported this to the Congregation when we led the Missions Church Service in January.

Because the banks have stopped accepting cheques we have had to change our banking arrangements. Our bank account is now linked to the Parish Accounts at ANZ Rangiora. We still have the same 3 people as Signatories to our account but have added Tracy Mayhew from the Parish Finance Team as an Administrator/Signatory. Tracy will help us do any banking on line from now on.

Hard Knox Café Report:

In April after a discussion with Moira and Terry Courtney's son Peter, (Teacher at Rangiora High) the Council began to look into the idea of using the space in the new Building proposal as a Youth dedicated area. This conversation was widened to include Wellbeing North Canterbury, the Waimakariri District Council, the Alpine Presbytery and Mission Fund and a number of Youth Community workers. As a result Terms of Reference were developed and funding was sought to explore the possibility of planting a Youth Ministry in the proposed build with an emphasis on support, drop-in and programmes around youth in the Rangiora Community. We are currently looking at a Feasibility Study to explore the need and opportunity associated with a project like this.

By October we should have a good indication of it's viability and if this is the direction we want to go, we will be looking at a partnership with the WDC, local schools, 24-7 and local youth initiatives as part of our new Building project.
